## PRODUCT INFORMATION

### Introduction

Sefacon is an equine health-enhancing supplement. It contains herbal extracts, supplements, and amino acids, specially blended and formulated into a solution.

Endocrine Technologies has partnered with various equine clinics to test this herbal supplement. Results have shown dramatic improvement in the subjects' energy and stamina. Horses that were suffering from an irregular gait or that were generally sluggish have shown marked improvement following treatment.

### Ingredients

Sefacon is a proprietary blend of various natural and scientific components. Only pure USP-approved ingredients are used in this supplement. Ingredients include Sugars (Sorbitol, Dextrose), Magnesium (Hydroxide), Aluminum (Hydroxide), Benzyl Alcohol (preservative), distilled water, natural cherry flavoring, FD&C Red # 40 coloring, Glycine, L-Lysine, L-Arginine, L-Tyrosine, L-Methionine, Biotin, Zinc, Folic acid, Aniseed extract, Chinese bitter gourd fruit extract and Fenugreek seed extract.

### Contents

Each order of Sefacon includes a 380mL bottle of the supplement solution, one plastic syringe and instructions, enough for 900lb horse. If your horse weighs more than 1000lb, contact Endocrine at 1-800-745-0843 for more info.

### Dosage & Use

The bottle of Sefacon solution should be shaken well before use. Sefacon should be administered orally. Horses are to be treated over the course of 8-9 consecutive days. Sefacon must be administered twice a day in 20mL doses (equivalent to 4 TEASPOONS), either orally using the syringe provided or mixed into a small amount of feed.

The dosage may vary for miniature horses and ponies.

The bottle of EXTRA STRENGTH SEFACON supplied (380ml) is enough for OVER 1000 LB horse only

### Side Effects

Sefacon is not known to cause any serious side effects currently. However, like all herbal supplements, Sefacon should not be mixed with any other medication or treatment.

### Storage & Shelf-life

Sefacon should be stored at cool temperature (4-8°C) and has a shelf life of six months.
